

ROLLS DOWN BANK TO BE CUT IN TWO BY ENGINE

Companions of Camden Boy Run Screaming From Scene When Grim Tragedy Occurs

Rolling down an embankment on to the tracks of the West Jersey and Seashore Railroad at Atlantic avenue, Camden, Otto Liebknecht, aged 7 years, of 1260 Mechanic street, went beneath the wheels of a shifting engine yesterday and was cut in twain. The accident occurred in the presence of several youthful companions who ran screaming away. Coroner Bushey gave an accidental death certificate.

At the point where the fatality occurred the company is constructing abutments preparatory to elevating its tracks and it was on one of the high embankments that young Liebknecht and his friends were playing. He was rolling about in the sand when the engine came along. The unfortunate boy gained so much momentum that he could not stop and he went directly beneath the wheels, which passed over the middle of his body, cutting it in two.

BOY BADLY HURT BY AUTO; INJURED FIREMAN DIES

Serious if not fatal injuries were received last night by Rudolph Deuter, aged 12 years, of 1776 South Sixth street, Camden, when he was run into by an automobile truck while riding on the rear of another. The boy was on the truck of the Gulf Refining Company at Broadway and Mechanic streets. Another truck in the rear and in charge of Harry M. Fletcher, Jr., of 2617 West Fletcher street, Philadelphia, ran into the forward one and pinned young Deuter to the back of the forward machine. Fletcher and John J. O'Rourke, who had the other truck, were held in nominal bail by order of Prosecutor Kraft to await the result of Deuter's injuries.

As a result of being struck in the face by an automobile crank on June 6, Fireman Joseph Ware, son of Policeman James Ware, died yesterday at his home at 1700 Fillmore street, Camden. He is survived by a wife and a young child. Ware was a member of No. 1 Engine Company and he operated the battalion chief's auto. After going to a fire at Locust and Pine streets he was cranking the machine when the handle slipped and he was struck in the face. The facial bones were crushed.

Stole to See "Movies," He Admits
