*While visiting Mrs. George T. Cabe, of 784 Walnut street, Camden, on behalf of a Lodge Monday night, Mrs. Euphemia Hart, aged 81 years, 623 West Clearfield street, Philadelphia, was stricken with paralysis. She died some hours later. The woman was a stranger to the Cabe and her name was only learned a short time before her death. Coroner Lippincott was notified and gave the necessary certificate for the removal of the body to Philadelphia. Mrs. Cabe, who is ill with the grip, suffered considerably from the shock incident to the woman's death and her condition is reported as being serious.

*Two Camden men had serious falls on the ice yesterday. Jonas Mellor, aged 70 years, of 1100 Broadway, slipped and fell near his home, receiving a serious concussion of the brain. A. Bear, a resident of North Camden, fell at Mills' shipyard, receiving three fractured ribs and internal injuries.

*Car No. 82, of the South Fifth street line, of the Camden and Suburban Railway Company, caught fire yesterday by the burning out of the motor box. At the time there were a number of passengers aboard, who hastily left the car. The flames were extinguished by the trolley crew.

*Harry Fisher, aged 16 years, of Millville, after spending less than a day in the world seeking his fortune, gave up his quest and surrendered to the Camden police yesterday. He was given transportation home.

*Mrs. Margaret Larzalere, aged 80 years, of 218 Linden street, Camden, dropped dead yesterday as she was leaving a store at 32 Market street, where she had just made some purchases. She was about to go out of the door when she fell. She was taken to the Cooper Hospital, where life was found to be extinct. County Physician Jones gave a certificate of death from heart disease.

*Allen C. Wood, aged 60¹ years, died yesterday at his home, 446 Lane street, from a complication of diseases. He was well known down town.

*Yesterday was the seventy-seventh anniversary of the incorporation of Camden.

*Albert Schairer was taken to state prison yesterday to serve eighteen months for breaking and entering the home of his brother-in-law.

*Joseph Pfeiffer gave a Dutch supper to the members of the Sixth ward Republican Club last night.

*Since Mayor Charles H. Ellis, of Camden, was inducted into the office he has been deluged with letters from all sorts and conditions of men who aspire to be policemen. In fact, there have been enough applications to provide for a dozen forces the size of that of Camden. The most unique of the lot, however, was received yesterday from a North Camden man, who said he and his seven sons have always been stalwarts and on this score asks to be appointed an officer. If he does not get the coveted position he avers he and his seven sons will support the Democrats.

*The Camden Excise Board will have a problem to solve at its meeting to-night when the liquor applications of John A. Walls and William Oberman come up for consideration. Both men have applied to sell at 505 Main street.

*Charges have been preferred against Policeman John Wagner and William Stanton, two Democratic police officers, who will be given hearings Friday night by the Police Committee of City Council. They are accused by James Butler with drinking while on duty.

*George S. Dillmore, Jr., yesterday morning heard burglars trying to bore out the lock on the back door at his home, 339 Kaighn avenue, Camden. Armed with a revolver, he quickly descended the stairway and discovered the thieves at work. Before he could shoot they disappeared over a back fence.
